**In-Ground Pool Opening:**

- \$269 – Pool Opening
- \$55 - Chemical Package

**What WE do at the time of the Pool Opening:** Remove & fold pool cover, remove plugs & gizzmos, reinstall return fittings, skimmer baskets and pump basket, install ladders & handrails, start filtration system and attempt to ignite the heater. A separate heater service call may be necessary if the tech cannot get the heater to ignite.

I have read, understand and agree with the payment policy and terms & conditions on both pages, and agree to pay all balances due at the time of service.

**Terms & Conditions:**

Only minor adjustments will be made at the time of the pool opening. Pool repairs are not done at the time the pool is opened. Repairs can be scheduled during a separate visit at a rate of \$185 plus tax (This includes the diagnostic fee and 1st half-hr labor for 1 man. If two-man crews are used a rate of \$45 per half-hour per man will be charged thereafter). We will inform the customer of all necessary repairs in writing and attempt to schedule a date for the repair.

**Customers responsibility PRIOR to our arrival:**

Leave the gates unlocked, have power to the pool, bring the water level up to the middle of the skimmer so we can complete the opening and start your pump and filter system, remove water, debris or leaves from top of pool cover (\$75 per 1/2 will be applied if we have to do it), leave D.E. powder out if you have a D.E. filter so we can replenish the grids, have ladders, hand rails, return fittings, skimmer baskets and pool cover by pool side.

**\* If Mystic Pools Technicians have to return because the above referenced is NOT done a \$100 return fee will be charged.**

**Customer’s responsibility AFTER pool opening:** We recommend you allow the water to circulate at least 24 hours before balancing. You should backwash and rinse the filter as needed to ensure proper circulation. If you have a cartridge filter make sure you keep the cartridges clean to ensure proper circulation. Vacuum the pool. Bring a water sample to our store to be tested.

**Missing parts during the Pool Opening:** To ensure proper start-up of your pool system, any missing or damaged parts will be replaced at our technicians’ discretion and customer will be charged for the cost of the part.

**Payment Policy:** Payment is due in full upon the completion of service, unless pre-payment with discount is selected. In that case the credit card will be charged when we receive the agreement and your opening is scheduled. All customers must have a valid credit card on file for payment and provide authorization of payment to Mystic Pool. The credit card on file will be used for any additional services provided. If no payment method is available at the time our technicians arrive, the scheduled service(s) will not be performed and an additional trip charge of \$75 will be applied for a return visit. A late payment will result in a finance charge of 1.5% per 30 days. By signing this agreement the customer is authorizing Mystic Pool to perform the service requested by customer and apply any late charges that may be incurred.

**Change & Cancellation Policy:** All changes or cancellations MUST be in writing within 48 hrs of the scheduled service.

**Limited Warranty:** All material, parts & equipment are warranted by the manufacturers or suppliers written warranty only. Mystic Pool makes no other warranties, expressed or implied and its technicians are not authorized to make any warranties on behalf of Mystic Pool. All labor performed by Mystic Pool, LLC is warranted for the first 30 days upon the completion of the service provided, or as otherwise indicated in writing. If any problems arise after the service is performed, we request that you please contact us immediately. Communication is the key to providing you with outstanding service; therefore, we reserve the right to resolve any issues.

**Verbal Commitment:** Under no circumstance is a verbal commitment a binding contract. Mystic Pools technicians are NOT authorized to make any verbal commitment with customers on Mystic Pool’s behalf.

**Diagnosis of a Problem:** Mystic Pool will attempt to diagnose or repair a major problem with the consent of the homeowner. Situations beyond our control will be made aware of to the homeowner in writing. We will try our best to resolve any problem in a timely matter. Promised service could be delayed beyond our control due to weather or availability.

**Credit Card Authorization:** By signing this document I hereby authorize Mystic Pool Supplies, LLC to perform the work necessary on my pool/property and agree to pay for the parts and labor charges as billed. I agree to pay the credit card company and not dispute the charges with them even though my signature is not on the individual credit card receipts. I fully acknowledge that I am signing this credit card authorization OUTSIDE OF THE RULES AND REGULATIONS OF MY CREDIT CARD COMPANY REFERENCED, BECAUSE AN IMPRINT OF MY CARD AND/OR MY SIGNATURE IS NOT POSSIBLE TO FACILITATE THIS TRANSACTION. Payment is due upon completion of the service being performed. In the event that the credit card charge is declined, I agree to pay these charges upon receipt of an invoice. A late payment will result in a finance charge of 1.5% per month. **Checks are not acceptable.** Customer is responsible for all court fees and attorney fees in the event that account is delinquent for 30 days,\* this is an estimate only. Mystic Pool Supplies, LLC reserves the right to revise this estimate if additional service is required to complete the project.
